Before a draft is begun the whole design should be conceived.

2

Nothing should be omitted or admitted at random.

3

A necessary result should never be stated.

4

Statements of Negotiation should be avoided.

5

The order of the draft should be logical.

6

The ordinary and accustomed forms of instruments & technical language should be employed

7

Language should be, to the utmost possible extent, precise and accurate that is, every phrase should have a clear meaning and all the phrases should be connected together as to give rise to no ambiguity.

8

While the precedent should not be followed mechanically, at the same time, as long as the precedent is not contrary to or inconsistent with the object to be achieved it should be followed verbatim.
